

OSWEGO COUNTRY CLUB ... 2019

FULL YEAR MEMBERSHIPS AND FEES

(Effective November 1, 2018)

GOLFING CLASSIFICATIONS:

JUNIOR SINGLE MEMBERSHIP... \$1660.00 + \$132.80 (TAX) = \$1792.80

Junior Single Memberships are only available to unmarried individuals at least eighteen (18) years of age but no more than thirty (30) as of November 1 who have no children under the age of twenty-one (21) years of age as of November 1. Each Junior Single Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Junior Single Member shall have the right to vote at any and all membership meetings and hold Club office.

JUNIOR FAMILY MEMBERSHIP... \$2030.00 + \$162.40 (TAX) = \$2192.40

Junior Family Memberships are only available to: 1) married couples or non-related domestic partners who permanently reside together (with or without children) who are each at least eighteen (18) years of age but no more than thirty (30) as of November 1, or 2) an unmarried individual at least eighteen (18) years of age but no more than thirty (30) as of November 1 who has children under the age of twenty-one (21) as of November 1. Each Junior Family Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Junior Family Membership shall include the married couple or qualifying non-related domestic partners and unmarried children. Each Junior Family membership shall have the right to one (1) vote at any and all membership meetings and shall allow one (1) adult to hold Club office.

SINGLE MEMBERSHIP... \$2470.00 + \$197.60(TAX) = **\$2667.60**

Single members shall be unmarried, including non-related domestic partner who permanently resides with the member, with no children under the age of twenty-one (21). Each single member of the Club shall have the full privilege of using all of the Club facilities, including practice range, within the established operational rules and limitations, and shall have the right to vote at any and all membership meetings and hold Club office.

FULL MEMBERSHIP... \$2910.00 + \$232.80 (tax) = \$3142.80

Full (Family) Memberships are for: 1) married couples or non-related domestic partners who permanently reside together (with or without children) one or both of whom are thirty-one (31) years of age or older as of November 1, or 2) an unmarried individual thirty-one (31) years of age or older as of November 1 who has children under the age of twenty-one (21) as of November 1. Each Junior Family Member of the Club shall have the full privilege of using all of the Club facilities within the established operational rules and limitations established by Club management. Each Junior Family Membership shall include the married couple or qualifying non-related domestic partners and unmarried children. Each Junior Family membership shall have the right to one (1) vote at any and all membership meetings and shall allow one (1) adult to hold Club office.

CORPORATE MEMBERSHIP... \$3500.00 + \$280.00 (tax) = **\$3780.00**

This membership is held in the name of and paid for by a company or organization. The company or organization designates one (1) individual to be the contact person who shall be the only individual authorized to deal with OCC in matters relating to this membership including, but not limited to, designating players and making any necessary payment arrangements. Corporate membership allows the company or organization who holds the membership up to fifty (50) 18-hole rounds of golf at Oswego Country Club (cart included) for employees and/or guests at no additional charge. Tee times arranged through the pro shop are required. Unless otherwise pre-approved by the Board, play is limited to a maximum of twelve (12) players per day but there shall be no other restrictions on weekday (non-holiday) play other than those imposed on all play (tournaments, leagues, etc.). The playing privileges of this membership may only be used after 11:00 AM on weekends and holidays.

NON-GOLFING CLASSIFICATIONS:

HOUSE MEMBERSHIP WITH POOL... \$610.00 + \$48.80 (TAX) = \$658.80

House w/ Pool members, whether single or family, shall have the privileges of the house <u>and pool</u> facilities within the established operational rules and limitations. They shall not be permitted to use the golf course or practice facility other than on a guest basis. House members are not eligible to vote at membership meetings or hold Club office.

HOUSE MEMBERSHIP WITHOUT POOL... \$300.00 + \$24.00 (TAX) = \$324.00

House w/o Pool members, whether single or family, shall have the privileges of the house facilities within the established operational rules and limitations. They shall not be permitted to use the golf course, practice facility or pool other than on a guest basis. House w/o pool members are not eligible to vote at membership meetings or hold Club office.

REQUIRED ANNUAL RESTAURANT / BAR MINIMUM:

FULL FAMILY & JUNIOR FAMILY MEMBERS / MARRIED HOUSE MEMBERS... \$300.00 + \$24.00 (tax) = \$324.00 SINGLE & JUNIOR SINGLE MEMBERS (GOLFING & NON-GOLFING)... \$200.00 + \$16.00 (tax) = \$216.00

OPTIONS:

LOCKER (PER LOCKER, PER SEASON) ... \$30.00 + \$2.40 (TAX) = \$32.40

CLUB CLEANING & STORAGE (INCLUDES LOCKER):

Small-upper unit ... \$70.00 + \$5.60 (TAX) = \$75.60

Small-lower unit \$90.00 + \$7.20 (TAX) = \$97.20

Large floor unit – single bag ... \$130.00 + \$10.40 (TAX) = **\$140.40**

Large floor unit - 2 bags ... \$175.00 + \$14.00 (TAX) = \$189.00

PRACTICE-RANGE (NON-GOLFING MEMBERS ONLY)

SINGLE USER ... \$50.00 + \$4.00 (TAX) = \$54.00

FAMILY (2 OR MORE USERS) ... \$75.00 + \$6.00 (TAX) = \$81.00
